The rate of Subsistence Allowance has been enhanced from 13.300/- per month to 13.750/- per month for the parents of persons killed in terrorist violence in the State of Funjab and in November, 1984 riots if they are having any living son(s).

The payment shall be effective from 1-10-1998. The expenditure involved is debitable to the
