No.8/259/90-RR-2/8109 The President of India is pleased to make the following amendment in the Subsistence Allowance to widows of Riots/ Terrorists violence Rules, 1990 published in the Punjab Covernment Gazett dated 10-5-1990 vide Punjab Government Notification No.8/259/90-RR-2/10778 dated 10-5-1990 and subsequent amendment made vide Notification No.8/259/90-RR-2/6211 dated 26-9-1990:-

- 1) These rules may be called SUBSISTENCE ALLOWANCE 'ID WIDD'S OF R TOTS/TERRORISTS V TOL ENCE (Ist AMENDMENT) RULES, 1991.
- ii) These rules shall be applicable throughout the State of Punjab.

FI.IGIBILITY

New clauses (ix), (x) and (xi) are added after the clause viii) below the Sub Rule (i) and (ii) of Rule 3 of Fligi i iv naruly :-

- i.) Widows/Orphans/Destitutes of Special Police Officers killed by terrorists/security forces acting in aid of civil power.
- x) Dep_endent parent(s) of the Special Police Officer ki by terrorists/security fo_rces acting in aid of civil power if he was married.
- xi) Dependent parent(s) of the Special Police Officer kill by the terrorists/security forces acting in aid of compower, if he was unmarried, provided, he was the solubreadwinner for his parent(s).

Provided that the subsistence allowance will stop as ar when the beneficiary or his/her nominee gets employed under pricategory No. 1.

RATE OF SUBSISTANCE ALLOWANCE

Subject to the provisions of Rules 7 and 10 the subsidial allowance payable to each applicant shall be @ Rs. 1000/- per mother dependent parent(s) as mentioned in clause (vii) and

of Rule 3, where the subsistance allowance shall be Rs. month. The amount shall be remitted through Eank Draft to claimants. Subsistance allowance under this scheme to the persons falling under clause (ix),(x) and (xi) is payable for the life time with effect from 1-7-1990.

POWER TO SANCTION FINANCIAL ASSISTANCE

The Sub-Divisional Officer (C) concerned shall be the sanctioning authority under this scheme. He/She shall pass orders in each case on the basis of the certificate referred to in the column of verification vide rule 5.
