No.8/259/90-RR-2/ 6211 The President of India is pleased to make the following amendment in the grant of Subsistance Allowance to the Victims of Riots/Terrorists Rules 1985 published in the Punjab Government Casette dated 21-11-1985, vide Punjab Government Notification No.13/330/3SW-65/9413 dated 18th Nov. 1985 ar subsequent amendments made vide Notification No.17/179/3SW-86/547 dated 16-1-1987, 17/175/86-3SW/13949 dated 21-12-1988 and 8/259/90-RR-2/10778 dated 10-5-1990.

- These rules may be called SUBSISTENCE ALLOWANCE TO WIDOW OF RIOTS/TERRORISTS VIOLENCE(2ND AMENDMENT) RULES, 1990.
- 1i) These rules shall be applicable throughout the State of Punjab.

Provisa to Sub-Para of Sub-Rule(i) and (ii) of Rule 3 shall be substituted as under:-

Provided that the Subsistence Allowance will stop as and when the beneficiary sets employed. However, a widow will continue to draw her Subsistence Allowance irrespective of any member of her family becoming an earning member in his/her own right. Where a job is given to a widow or her nominee under the Guaranteed Employment Scheme, under Priority category No.1. the subsistence allowance will stop from the date such a job is given to the widow or her nominee.
