The Governor of Punjab is pleased to make the following amendment in the Subsistence Allowance to widows of riots/ terrorist violence Rules, 1990 published in the Punjab Government Gazette dated 10.5.1990 vide Punjab Government Notification No. 8/259/90-RR-2/10778, dated 10.5.1990 and subsequent amendments made vide Notification No. 8/259/90-RR-2/6211, dated 26.9.1990; No. 8/259/90-RR-2/8109, dated 11.7.1991; and No. 8/259/90-RR-2/504, dated 22.1.1992:-

- i) These rules may be called SUBSISTENCE
 ALLOWANCE TO WIDOWS OF RIOTS/ TERRORIST
 VIOLENCE (2nd AMBINDMENT) RULES, 1992.
- ii) These Rules shall be applicable throughout the State of Punjab.

RATE OF SUBSISTENCE ALLOWANCE

The rate of subsistence allowance has been enhanced from R.1000/- per month to R.1500/- per month for the terrorist affected widows and for both the parents or mother alone or father alone, if alive, in case their only son or all sons (married or un-married) are killed by the terrorists. It has also been decided to pay the subsistence allowance at the rate of R.300/- per month to both the parents or mother alone or father alone, if their any sun is alive.

These allowances would be in addition to the subsistence allowance payable to the widows.

EFFECT

The payment shall be effective from 1.4.1992.

POWER TO SANCTION SUBSISTENCE ALLOWANCE

The Sub-Divisional Officer (C) concerned shall be the sanctioning authority under this scheme. He/she shall pass orders in each case, after due verification.
