The Government of Punjab is pleased to make the following amendment in the Subsistence allowance to Widows of Riots/Terrorist Violence Rules, 1990 published in the Punjab Government Gazette dated 10.5.1990 vide Punjab Government Notification No.8/259/90-RR.2/10778, dated 10.5.1990 and subsequent amendments made vide Notification No.8/259/90-RR.2/6211, dated 26.9.1990; No.8/259/90-RR.2/8109, dated 11.7.1991; No. 8/259/90-RR.2/504, dated 22.1.1992; No.8/259/90-RR.2/936, dated 30.9.1992; No. 6/137/92-RR.2/13763, dated 25.7.1994 and No. 6/137/92-RR.2/2 20150, dated 30.9.1994.

- ii) These Rules shall be applicable throughout the State of Punjab.

ELIGIBILITY

rvii) The minor children, after the death of a widow in receipt of Subsistence Allowance on account of the death of her husband in terrorists violence in the State of Punjab or in action by security forces against terrorists or otherwise.

Provided the subsistence allowance will stop as and when the beneficiary (s) gets employed under priority category No. 1.

RATE OF SUBSISTENCE ALLOWANCE

The rate of Subsistence Allowance will be equal to the subsistence allowance admissible to orphans in terms of the State Government instructions issued from time to time. If the

jumber of children exceeds one, the subsistence allowance shall be paid in equal shares.

EFFECT Under Rule 7(ii)

The payment shall be payable with effect from 29.4.1991.

POWER TO SANCTION SUBSISTENCE ALLOWANCE

The Sub-Divisional Officer (C) concerned shall be the sanctioning authority under this scheme. He/she shall pass orders in each case after verification.
