NOTIFICATION

No.6/221- RR- 2/17490 . The Governor of Punjab is pleased to make the following amendment in the Subsistence Allowance to widows of riots/ terrorist violence Rules, 1990 published in the Punjab Government Gazette dated 10.5.1990 vide Punjab Government Notification No. 8/259 /90- RR-2/ 10778, dated 10.5.1990 and subsequent amendments made vide Notification No.8/259/90-RR-2/ 6211, dated 26.9.1990; No. 8/259/90- RR- 2/8109, dated 11.7.1991; No.8/259/90- RR- 2/ 504, dated 22.1.1992; No. 8/259/90- RR- II/936 dated 30.9.1992; No. 6/137/97 - RR- 2/13762 dated 25.7.94; No. 6/130/94- RR-/ 20150 dated 30.11.1994; No. 6/137/92- RR- 2/5606 dated 31.3.1995 ; No. 8/67/94- RR- 2/ 2930 dated 16.2.1996 and No.10/23/ 96- RR- 2/ 15999 dated 26.11.1996:-

- i) These rules may be called SUBSISTENCE ALLOWANCE TO WIDOWS OF RIOTS/ TERRORIST VIOLENCE ( 3rd AMENDMENT) RULES, 1996.
- ii) These Rules shall be applicable throughout the State of Punjab.

RATE OF SUBSISTENCE ALLOWANCE

The rate of subsistence allowance has been enhanced from Rs. 1500/- per month to Rs. 2500/- per month, for the widows of terrorist victims, as well as to those dependent parents whose only or all sons were killed in terrorist violence; and to those persons who have sustained permanent disability, exceeding 70 percent, in terrorist's violence. It shall continue to be paid to widows, even if their children get Government employment.

Proviso to Sub-Para of Sub-Rule (i) and (ii) of Rule 3 shall be substituted as under:-

Provided that the Subsistence Allowance will stop as and when the beneficiary gets employed. The subsistence allowance shall <sup>now</sup> be revived to <sup>those</sup> widows, which was earlier stopped, after getting jobs by their nominees, sons or daughters, under priority category No.1.

EFFECT

The payment shall be effective from 1-1-1997.
