NOTIFICATION

No. S.O. 4/ P.A.17/1887/S.27/2025.- In exercise of the powers conferred by section 27 of Punjab Land Revenue Act, 1887 (Act No. XVII of 1887), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to confer certain powers upon the officers of the Excise Commissionerate, Department of Excise and Taxation, Punjab, so specified in the Table given below, which shall be exercised within their respective jurisdiction, for the purpose of collection of excise revenue under the Punjab Excise Act, 1914, with effect from 8th October, 2018, namely:-
