## THE INDIAN STAMP (PUNJAB AMENDMENT) <br> ORDINANCE, 2019 <br> (Punjab Ordinance No. 1 of 2019) <br> AN <br> ORDINANCE

further to amend the Indian Stamp Act, 1899 , in its application to the State of Punjab.

Promulgated by the Governor of Punjab in the Sixty-ninth Year of the Republic of India.

Whereas the Legislative Assembly of the State of Punjab is not in session and the Govemor is satisfied that circumstances exist, which render it necessary for him to take immediate action;

Now, therefore, in exercise of the powers conferred by clause (1) of article 213 of the Constitution of India, the Governor of Punjab is pleased to promulgate the following Ordinance, namely:-

1. (I) This Ordinance may be called the Indian Stamp (Punjab Amendment) Ordinance, 2019.

Short title and
(2) It shall come into force on and with effect from the date of its publication in the Official Gazette.
2. In the Indian Stamp Act, 1899, in its application to the State of Punjab, in Amendment in Schedule 1-A, under the column, captioned as "Proper Stamp-duty",- Schedule 1-A of

(2) against entry 3, for the words "Five hundred rupees", the words "One thousand rupees" shall be substituted:
(3) against entry 4, for the words "Twenty five rupees", the words "liifty rupees" shall be substituted;
(4) in entry 5.-

(10) in entry 39.
(i) against item (a). for the words "Five thousand rupees", the words "Ten thousand rupees" shall be substituted; and
(ii) against item (b), for the words "Ten thousand rupees", the words "Twenty thousand rupees" shall be substituted:
(1) against entry 42, for the words "Forty five rupees", the words "Ninety rupees" shall be substituted;
(12) in entry 46 .-
(i) under the heading. captioned as "A-Instrument of-", against item (b), for the words "One thousand rupees", the words "Two thousand rupees" shall be substituted; and
(ii) under the heading. captioned as "B-Dissolution of-". for the words "Fifty rupees", the words "One Hundred rupees" shall be substituted;
(13) in entry 48. -
(i) against item (a), for the words "Five hundred rupees", the words "One thousand rupees" shall be substituted:
(ii) against item (b), for the words "Five hundred rupees". the words " One thousand rupees" shall be substituted;
