The Government proposes to set up a Revenue Commission in order to make the existing laws, procedures and processes relating to land administration in tune with the requirements of modern agricultural and non-agricultural uses, propose new laws and procedures, and other matters to make revenue Administration more transparent and responsive to the needs of the people. The Revenue Commission shall have the following composition:-

2. Punjab Land Records Society will provide Secretarial assistance to the Commission. Such Officers of the Revenue Department and other relevant Departments of the State Government as are required shall also be associated to support the Commission. The Commission may associate such experts as it considers necessary.

3. The Commission shall submit its report on the issues referred to it from time to time. It will remain in existence for one year or as decided by the Government. The Commission will have sittings depending upon its requirements.

4. The Commission will, inter-alia consider the following:-


1. Review of the organisational structure of Revenue Administration in view of the latest developments in IT and the

aspirations, expectations, needs and requirements of the contemporary Punjabi society.

2. The Commission will suggest norms of population, area etc. for all administrative units viz Division, District, Sub-Division, Tehsil, Sub-Tehsil, Kanungos & Patwar circle.
3. Examination of Punjab Land Revenue Act, 1887, Punjab Tenancy Act, 1887, Punjab Land Reforms Act, 1972 and other related Acts and Manuals administered by the Department of Revenue, in view to see their relevance in the present scenario of land use and land holdings, etc. The Commission will suggest amendments in the existing Acts, Rules and Manuals and will also suggest the repeal of existing Acts, Rules and Manuals etc., which have become out dated and are no more required.
4. Enactment of new Acts and Rules if required in view of emerging requirements of land for the use of Agriculture and Industry.
5. Whether the State should move towards a system of conclusive title in place of existing presumptive title and if yes, the procedures thereof.
6. Review of existing policies with regard to disposal/utilisation of Government lands esp. Nazool land, evacuee land, muafi land and suggest amendments thereto.
7. Review of the existing Act and Rules pertaining to Urban Properties in order to protect the rights of people in urban land, maintenance of record and procedure.
8. The Commission may in its wisdom suggest measures or give observations regarding the Acts and Rules etc., administered by other Departments of the Government of Punjab to minimise the frictions therein and to achieve the much needed cohesiveness between them.

5. The Commission will devise its own procedures for its functioning. It may call for and study any record/files/reports of any department under the Government of Punjab. It may visit anywhere in India for perusal and study of such records and procedures as it may deem proper.

6. The terms and conditions of the Chairman and Members shall be separately notified.


