**No. S.O.71/P.A.17/1887/S. 5/C.A.16/1908/S.5/2016.**-In partial modification of the Government of Punjab, Department of Revenue and Rehabilitation, Notification No. 12/4/2000-RE-II(1)/8213, dated the 21st December, 2001 and in supersession of the Government of Punjab, Department of Revenue, Rehabilitation and Disaster Management, Notification No. S.O. 55/P.A.17/ 1887/ S.5/ C.A.16/ 1908/ S.5 /2015, dated the 25th November, 2015, and in exercise of the powers conferred by Section 5 of the Land Revenue Act, 1887 (Act XVII of 1887) and Section 5 of the Registration Act, 1908 (Act 16 of 1908), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to alter the limits of the certain tehsils, on and with effect from the **1st October, 2016**, to from a new Sub District, to be known as Sub-Division, Majitha (with its headquarters at Majitha), consisting of the areas as specified in the Table given below, to be its territorial jurisdiction, namely:-
