
The 8 February, 2019

Notification No. 14/5/2018-RC-1/1777 The Government vide its Notification No. 14/5/2018-RC-1/3348 Dated 13/2/2018 had set up a Revenue Commission in order to make the existing laws, procedures and processes relating to land administration in tune with the requirements of modern agricultural and non-agricultural uses, propose new laws and procedures and other matters to make revenue administration more transparent and responsive to the need of the people. The tenure of the Commission was for one year or as decided by the Government.

2 The work assigned to the Commission is quite voluminous and time consuming. The tenure of the Commission is therefore further extended for a period of one year i.e. till 12.02.2020.

3 The terms and conditions as specified in Notification No. 14/5/2018-RC-1/3364 Dated 13/2/2018 and 14/5/2018-RC-5/12014 Dated 05/6/2018 will remain the same.
